**AGREED ORDER**

On this day the Texas Board of Veterinary Medical Examiners ("Board") considered the matter of the license of Leah Atwood, D.V.M. ("Respondent").

Respondent, without admitting the truth of the Findings of Fact and Conclusions of Law set out in this Order, waived notice and hearing and agreed to the entry of this Order. Accordingly, the Board makes the following Findings of Fact and Conclusions of Law and enters this Order as set forth below.

**FINDINGS OF FACT**

1. Respondent, Leah Atwood, D.V.M., of Allen, Texas, holds Texas veterinary license #10973.
2. On or about June 17, 2021, Respondent treated a dachshund, "Pickle," for gastrointestinal issues and Pickle had recently been seen on several other previous occasions.
3. The veterinarian did a radiograph on one prior visit which was not presented for evaluation. The Respondent said the radiograph was unremarkable.
4. The client requested bloodwork, but tests were not done because the Respondent felt they would be unremarkable.
5. The client mentioned a concern about a lump on Pickle's side. The Respondent was unable to locate the lump and failed to order any other diagnostic testing.
6. The Respondent only treated Pickle symptomatically.
7. After the last exam by Respondent, Pickle rapidly declined in a matter of hours.
8. Pickle died on the way to the emergency clinic. The veterinarian at the emergency clinic diagnosed the Pickle with a swollen liver with neoplasia.

**CONCLUSIONS OF LAW**

1. Pursuant to Texas Occupations Code, Chapter 801, the Board has jurisdiction over this matter. Respondent is required to comply with the provisions of the Veterinary Licensing Act, Chapter 801, Texas Occupations Code, and with the Board's Rules. Respondent received notice as required by law.
2. Respondent has violated Board Rule 573.22, Standard of Care, of the Board's Rules of Professional Conduct.
3. Respondent has violated Section 801.402(6) of the Veterinary Licensing Act, Texas Occupations Code, prohibiting "practices or conduct that violates the board's rules of professional conduct."
4. Respondent is subject to disciplinary action under Texas Occupations Code, Sections 801.401(a), and 801.451.
5. Pursuant to Board Rule 575.25, Respondent's violations are Class B violations, and Respondent is subject to disciplinary action under that Rule.

#### **TERMS OF ORDER**

Now, therefore, the Board and Respondent agree to the following terms:

1. REPRIMAND
  - a. Respondent is hereby formally reprimanded by the Board. This formal reprimand may be published in the Board's newsletter and routinely reported to the American Association of Veterinary State Boards (AAVSB) for inclusion in the national reporting database.
2. ADMINISTRATIVE PENALTY
  - a. Respondent shall pay an administrative penalty of one thousand five hundred dollars (\$1,500.00) within 30 days of the date the Board approves this Order. Payment shall be made directly to the Texas Board of Veterinary Medical Examiners at 1801 Congress Avenue, Suite 8.800, Austin, Texas 78701. Partial payments will not be accepted.
  - b. If Respondent does not timely pay the administrative penalty, the Board may deny a request to renew Respondent's license until the outstanding administrative penalty is received, pursuant to Board Rule 573.62(b). Any monetary funds paid to the Board to renew a license shall first be applied to any outstanding unpaid administrative penalties, pursuant to Board Rule 571.57. Additionally, the matter may be referred to the Attorney General for collection, pursuant to Texas

Occupations Code, Section 801.458.

3. CONTINUING EDUCATION

- a. In addition to the annual continuing education required for license renewal, Respondent shall complete three (3) hours of continuing education in the area of "Oncology" and three (3) additional hours of continuing education in the area of "Internal Medicine" within six months of the date the Board approves this Order. Respondent shall submit documentation of the completed continuing education penalty and the required annual continuing education to the Board within six months of the date the Board approves this Order. Documentation shall be submitted directly to the Texas Board of Veterinary Medical Examiners at 1801 Congress Avenue, Suite 8.800, Austin, Texas 78701.

4. ADHERENCE TO THE LAW AND BOARD RULES

- a. Respondent shall abide by the Board's Rules of Professional Conduct, the Texas Veterinary Licensing Act, and the laws of the State of Texas and the United States.
- b. Respondent shall cooperate with the Board's attorneys, investigators, compliance officers and other employees and agents investigating Respondent's compliance with this Order.
- c. Failure by Respondent to comply with the terms of this Order, or with any other provisions of the Veterinary Licensing Act or the Board Rules, may result in further disciplinary action.

The effective date of the terms of this Order shall be the date it is adopted by the Board, unless stated otherwise.


