FINDINGS AND ORDERS OF THE BOARD

On this the 21st day of January, A.D., 1964, THE TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS being in regular meeting at the Sands Motel in College Station, Brazos County, Texas, such meeting being called for the purpose of hearing and considering the above numbered and entitled complaint as well as for the consideration of other business, and the above entitled and numbered complaint having been previously scheduled for hearing and the said DR. GEORGE ROGER CADWALDER having waived service of citation and accepted service in said cause by sworn instrument dated the 6th day of January, 1964, and a quorum of the members of THE TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS being present, to-wit:

whereupon the President of the Board, DR. HORACE T. BARRON, ordered the hearing to proceed at which time it was ascertained that DR. GEORGE ROGER CADWALDER was present in person. The Board then proceeded to hear all the evidence presented on behalf of the STATE and the said DR. GEORGE ROGER CADWALDER. After such hearing, the Board went into executive session to consider the evidence and after consideration and deliberation of all the evidence that had been presented, THE TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS, on the same day, Tuesday, January 21, 1964, all of the above members of the said Board being present and participating made the following findings and orders to-wit:

FINDINGS

1. The Board finds that all statutory requisites to its jurisdiction have been met.

2. The Board is of the opinion that for a period of approximately three (3) months during the year 1952 as alleged in count number 1 of said complaint, the said DR. GEORGE ROGER CADWALDER, Texas Veterinary Medical License No. 1561, 1963-64 Renewal Certificate No. 1215, was addicted to the use of narcotic drugs while undergoing medical treatment and withheld said fact of addiction from the Board upon making application to the Board for a License to practice Veterinary Medicine in this State; the Board is further of the opinion that the charges contained in counts number 2, 3, and 4 are true and further finds that the said DR. GEORGE ROGER CADWALDER was guilty of dishonest and or illegal practices in or connected with the practice of veterinary medicine in that he did purchase narcotic drugs for self injection by use of the Federal Narcotic permit contrary to the purposes for which the said permit was issued; and that during the period of July, 1955 through January 1962, he did obtain narcotic drugs by executing and passing fraudulent prescriptions, and that during this period of time the said DR. GEORGE ROGER CADWALDER did administer unto himself narcotic drugs in such quantities and with such frequency so as to be addicted to the use of narcotic drugs, all of which are within the contemplation of Sections 14 and 15 of Article 7465a Revised Civil Statutes of Texas, as charged in said complaint.

The Board finds that the fact brought out at such hearing justify and require the following orders:

ORDERS

It is ACCORDINGLY ORDERED, ADJUDGED and DECREED that Texas Veterinary Medical License No. 1561 and 1963-64 Renewal Certificate No. 1215 heretofore issued by the TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS to DR. GEORGE ROGER CADWALDER, be and the same are HEREBY SUSPENDED FOR A PERIOD OF FIVE (5) YEARS FROM THE DATE OF THIS ORDER, PROVIDED HOWEVER, that the execution of this order of SUSPENSION be and it is HEREBY STAYED, and the said DR. GEORGE ROGER CADWALDER is placed upon PROBATION for a period of five (5) years upon the following terms and condition:

1. The said DR. GEORGE ROGER CADWALDER will not engage in any dishonest or illegal practices in or connected with the practice of veterinary medicine within the State nor violate any of the provisions of Article

7465a, of the Revised Civil Statutes of Texas, or any of the Statutes of Texas or any additions or amendments thereto pertaining to veterinary Medicine.

2. The said DR. GEORGE ROGER CADWALDER will observe and abide by each of the Rules of Professional Conduct promulgated by the State Board of Veterinary Medical Examiners of the State of Texas for licensed veterinarians now in effect or placed in effect during said period of suspension or any part of said period.

3. That the said DR. GEORGE ROGER CADWALDER will not make an application for nor attempt to secure a narcotic stamp or permit from the Federal Bureau of Narcotics at any time during the five year suspension period herein ordered.

4. The said DR. GEORGE ROGER CADWALDER shall file with the Executive Secretary of the STATE BOARD OF VETERINARY MEDICAL EXAMINERS at semi-annual intervals, an affidavit to the effect that he has fully and faithfully complied with the terms and conditions of the probation herein imposed. Said affidavits shall be transmitted to the Board Offices by Certified United States mail, return receipt requested. Said affidavits shall be executed by DR. GEORGE ROGER CADWALDER so as to be received in the Board offices on or before the 1st day of January and on or before the 1st day of July of each consecutive calendar year for the period of said probation, the first said affidavit to be received in the Board offices on or before the 1st day of July, 1964.

It is further ORDERED, ADJUDGED and DECREED that upon full compliance with the terms and conditions herein set forth, and upon expiration of the term of probation, the license of the said DR. GEORGE ROGER CADWALDER and the annual renewal certificate then in effect shall be restored to its full privileges, free and clear of the terms of probation herein imposed; PROVIDED HOWEVER, that in the event the said DR. GEORGE ROGER CADWALDER violates or fails to comply with any of the terms or conditions of this order during said period of probation, the Board, upon receipt by it of satisfactory evidence thereof, may forthwith terminate said probation, cancel and revoke said stay of execution and direct that the order of suspension herein made become effective immediately.

BEFORE ME, a Notary Public in and for Travis County, Texas, on this day personally appeared T. D. WEAVER, who after being by me duly sworn upon oath deposes and says that:

The said T. D. WEAVER, being the Executive Secretary of the Texas State Board of Veterinary Medical Examiners, did in the course of his employment make certain investigations into the professional conduct of one DR. GEORGE ROGER CADWALDER, Texas Veterinary Medical License No. 1561, 1963-1964 Renewal Certificate No. 1215, a practitioner of veterinary medicine in the State of Texas, and in the course of said investigation it has come to the attention of the said T. D. WEAVER that on or about the dates hereinafter specified that the said DR. GEORGE ROGER CADWALDER did commit one or more of the following acts, and/or omissions, or a combination thereof or all of same, said acts and/or omissions being in violation of Article 7465a of the Civil Statutes of Texas (V. A. T. S.) and within the contemplation of Section 14 and 15 of said statute, as follows, to-wit:

1. That during the period of time from November 1952 up to and including May 1954, the said DR. GEORGE ROGER CADWALDER did administer unto himself narcotic drugs in such quantities and with such frequency as to become addicted to the use of narcotic drugs and upon making application to the Texas State Board of Veterinary Medical Examiners for examination for a license to practice veterinary medicine in the State of Texas said DR. GEORGE ROGER CADWALDER failed to disclose his addiction to the use of narcotic drugs.
2. That during the period of time from July 1954 through January 1962 the said DR. GEORGE ROGER CADWALDER did administer unto himself narcotic drugs in such quantities and with such frequency so as to be addicted to the use of said narcotic drugs.
3. That during the period from July 1954 through December 1958, on numerous occasions the said DR. GEORGE ROGER CADWALDER did obtain narcotic drugs for the purpose of self-injection by the use of the Federal Narcotic Permit contrary to the purpose for which the narcotic permit was issued by the Federal Bureau of Narcotics.
4. That on numerous occasions between July 1954 and January 1962, the said DR. GEORGE ROGER CADWALDER did execute and issue fraudulent prescriptions

for the purpose of obtaining narcotic drugs for self-injection.


The above complaint, containing four (4) counts, is submitted to the Texas State Board of Veterinary Medical Examiners this the 2nd day of January A.D., 1963.
