FINDINGS, CONCLUSIONS AND ORDERS OF THE BOARD

On the 6th day of May, A.D., 1978, the TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS, being in regular meeting at the Holiday Inn Northeast in Hurst, Tarrant County, Texas, such meeting being called for the purpose of hearing and considering the above numbered and entitled complaint, as well as for the consideration of other business, and the above entitled and numbered complaint having been previously scheduled for hearing and Defendant, the said DR. EMIL W. CROW, having waived Service of Citation and accepted service in said cause by sworn instrument dated the 18th day of April, 1978, and the entire membership of the TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS being present, to wit:

whereupon the President of the Board, DR. WALLACE H. CARDWELL, ordered the case to proceed at which time it was ascertained that DR. EMIL W. CROW was present in person; whereupon Respondent, DR. EMIL W. CROW entered his plea of "Guilty" to the said docketed complaint and all counts thereof; whereupon the Board then proceeded to hear the evidence presented by the State, and by DR. EMIL W. CROW, in his behalf, and on the same day, Saturday, May 6, 1978, all of the above members of said Board being present and participating, makes the following findings, to-wit:

FINDINGS OF FACT

1. The Board finds that all statutory requisites to its jurisdiction have been met.

2. That the said DR. EMIL W. CROW, on or about the days hereinafter set out, did obtain the following listed dangerous drugs and/or controlled substances from Gibson's Pharmacy, 920 Pioneer Parkway, Arlington, Tarrant County, Texas, when in fact no such individual existed and/or resided at the address contained on said prescriptions, and that such acts or omissions resulted in the writing of fictitious prescriptions,

CONCLUSIONS OF LAW

That writing of fictitious prescriptions for, and obtaining dangerous drugs and/or controlled substances, is a violation of Article 7465a, Subsections (c) and (e) of Section 14 of Vernon's Annotated Texas Statutes, and Section 14 of Article 4476-14 and Section 4.09 (a) (3) of 4476-15 of Vernon's Annotated Texas Statutes.

The Board finds that the facts and conclusions brought out at such hearing justify and require the following orders:

ORDERS OF THE BOARD

It is hereby ORDERED that Texas Veterinary Medical License No. 1510 and 1978 License Renewal Certificate Number 518 heretofore issued to DR. EMIL W. CROW, by the TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS be, and the same is HEREBY REVOKED on this the 6th day of May, 1978, and the said DR. EMIL W. CROW shall not hereafter practice veterinary medicine in the State of Texas.


It is further ORDERED that said DR. EMIL W. CROW shall forthwith return the aforesaid license to practice veterinary medicine and the 1978 renewal certificate to the offices of said Board at 603 Capital National Bank Building, Austin, Texas 78701, by Certified Mail, Return Receipt Requested.

The above findings and orders of the TEXAS STATE BOARD OF VETERINARY MEDICAL EXAMINERS are entered as the order of the BOARD by a unanimous vote of the members of the Board all of whom were present and participating in such hearing, deliberation and decision, and such findings and orders are hereby made on this the 6th day of May, 1978, at Hurst, Tarrant County, Texas.





The said ERNIE M. CARROLL, being an employee of the Texas State Board of Veterinary Medical Examiners, did in the course of his employment make certain investigations into the professional conduct of one DR. EMIL W. CROW, Texas Veterinary Medical License No. 1510, 1978-1979 Renewal Certificate No. 518, a practitioner of veterinary medicine in the State of Texas, and in the course of said investigation it has come to the attention of the said ERNIE M. CARROLL that on or about the dates hereinafter specified that the said DR. EMIL W. CROW did commit one or more of the following acts, and/or omissions, or a combination thereof or all of same said acts and/or omissions being in violation of Article 7465a of the Civil Statutes of Texas (V.A.T.S.) and within the contemplation of Section 14 and 15 of said statute, as follows, to-wit:

That on or about the dates hereinafter indicated the said DR. EMIL W. CROW did knowingly write prescriptions for fictitious persons and personally obtain certain dangerous drugs and/or controlled substances in the amounts stated from Gibson's Pharmacy, 920 Pioneer Parkway, Arlington, Tarrant County, Texas when in fact no such individual existed and/or resided at the addresses contained on said prescriptions.
