### AGREED ORDER

On this day the Texas Board of Veterinary Medical Examiners ("Board") considered the matter of the license of Laurel Douglass, D.V.M. ("Respondent").

Respondent, without admitting the truth of the Findings of Fact and Conclusions of Law set out in this Order, waived notice and hearing and agreed to the entry of this Order. Accordingly, the Board makes the following Findings of Fact and Conclusions of Law and enters this Order as set forth below.

## FINDINGS OF FACT

- 1. Respondent, Laurel Douglass, D.V.M., of Houston, Texas, holds Texas veterinary license 10023.
- 2. On October 19, 2016, Kathy Davis presented her seven month old King Charles Cavalier, George, to Respondent at Sunset Boulevard Animal Clinic in Houston, Texas, for a neuter procedure. Respondent performed the procedure. Respondent instructed facility employees to remove an intravenous (IV) catheter prior to discharge, however the IV catheter was still in place when George was discharged at approximately 6 p.m. Respondent was not present when George was discharged. MS. Davis returned the following day and the catheter was removed without incident.

#### CONCLUSIONS OF LAW

- 1. Pursuant to Texas Occupations Code, Chapter 801, the Board has jurisdiction over this matter. Respondent is required to comply with the provisions of the Veterinary Licensing Act, Chapter 801, Texas Occupations Code, and with the Board's Rules. Respondent received notice as required by law.
- 2. Respondent has violated Board Rule 573.10, Supervision of Non-Veterinarians, of the Board's Rules of Professional Conduct.
- 3. Respondent has violated Board Rule 573.11, Responsibility for Unlicensed Employees, of the Board's Rules of Professional Conduct.
- 4. Respondent has violated Section 801.402(6) of the Veterinary Licensing Act, Texas Occupations Code.

- 5. Respondent is subject to disciplinary action under Texas Occupations Code, Sections 801 401(a), and 801.451.
- 6. Pursuant to Board Rule 575.25, Respondent's violations are Class C violations, and Respondent is subject to disciplinary action under that Rule.

## TERMS OF ORDER

New, therefore, the Board and Respondent agree to the following terms:

## REPRIMAND

a. Respondent is hereby informally reprimanded by the Board. This informal reprimand will not be published in the Board's newsletter and will not be routinely reported to the American Association of Veterinary State Boards (AAVSB) for reported to the American Association of Veterinary State Boards (Figure 1997) inclusion in the national reporting database. A copy of this informal reprimand will be forwarded to the AAVSB if specifically requested by that organization.

# 2 ADHERENCE TO THE LAW AND BOARD RULES

- a. Respondent shall abide by the Board's Rules of Professional Conduct, the Texas Veterinary Licensing Act, and the laws of the State of Texas and the United States.
- b. Respondent shall cooperate with the Board's attorneys, investigators, compliance officers and other employees and agents investigating Respondent's compliance with this Order.
- c. Failure by Respondent to comply with the terms of this Order, or with any other provisions of the Veterinary Licensing Act or the Board Rules, may result in further disciplinary action.

The effective date of the terms of this Order shall be the date it is adopted by the Board, unless saured otherwise.
